TERMS AND CONDITIONS

HOLIDAY CAMPS

SUMMER AND WINTER CAMPS

1. REGISTRATION AND PAYMENT

- 1.1. By registering for the holiday camps, students and legal guardians agree to abide by the general terms and conditions of Swiss Boarding Schools Disentis & Zürich (hereafter SBSZ).
- 1.2. Full payment must be received minimally one month before the start of the camps. Failure to make payment may result in the cancellation of the reservation.
- 1.3. A written confirmation will be issued within 5 days of receipt of the full payment. With the confirmation and the receipt of your deposit, participation is guaranteed.
- 1.4. Required documents for camp acceptance are: Valid passport or identity card.

2. CANCELLATION AND REFUNDS

- 2.1. Participation on the holiday camps can be cancelled at any time and must be communicated in advance to SBSZ in writing.
- 2.2. Cancellations made 31 days or more prior to the start of the camps will be eligible for a partial refund of 75% of the basic fee.
- 2.3. Cancellations made 30 to 15 days prior to the start of the camps will be eligible for a partial refund of 50% of the basic fee.
- 2.4. For cancellations made less than 15 days prior to the start of the camps, no refund will be given.
- 2.5. For non-appearance, no refund will be given.
- 2.6. Refunds for cancellations resulting from force majeure events, including illness and accidents, will not be granted.
- 2.7. Students and legal guardians are responsible for covering any bank transfer charges incurred due to the refund process.

3. HEALTH AND MEDICAL

- 3.1. Students are required to provide accurate medical and health information during registration.
- 3.2. Students are required to provide accurate immunization records during registration.
- 3.3. Students with pre-existing medical conditions or dietary requirements should inform SBSZ at least 30 days in advance.
- 3.4. SBSZ reserves the right to seek medical attention for students in case of emergencies and to administer necessary medications.

4. CODE OF CONDUCT

- 4.1. Students are expected to behave in a respectful and responsible manner towards fellow students, staff, and property.
- 4.2. Bullying, harassment, or disruptive behaviour will not be tolerated and may result in immediate expulsion from the camps without a refund.
- 4.3. Consumption, possession and trafficking of alcohol or drugs will not be tolerated and may result in immediate expulsion from the camps without a refund.
- 4.4. Students are not permitted to keep any pets at school.



5. LIABILITY

- 5.1 SBSZDZ guarantees expert class instruction based on an institutional teaching plan together with a meaningful boarding experience within the limits of a holiday program.
- 5.2 Within the scope of due diligence, Swiss Boarding School Disentis and Zurich is liable for the content of the promised services. Liability is limited to the amount of the camp price.
- 5.3 SBSZDZ is not responsible for any loss, theft, damage, or injury to personal property or persons during the stay.
- 5.4 Students and legal guardians release SBSZDZ and staff from any liability related to accidents, injuries, or illnesses that may occur during the stay.

6. INSURANCE

- 6.1 Students are obliged to take out health and accident insurance as well as liability insurance during their stay in the camps. It is the responsibility of each student to ensure they have adequate insurance coverage for the duration of their time on the camp.
- 6.2 Upon departure, students are responsible for taking all their belongings with them or for making any necessary shipping arrangements. The school is not responsible for any items left behind.
- 6.3. Students should not bring any valuable items or large sums of money to the camp (however, if necessary, such items may be deposited with the school for safekeeping).

7. CHANGES AND CANCELLATIONS BY THE CAMPS

- 7.1 SBSZDZ reserves the right to modify the camp schedule, activities, or location due to unforeseen circumstances.
- 7.2 Should unforeseen circumstances lead to the cancellation of the camps by SBSZDZ, students will receive a complete refund of the paid amount. However, SBSZDZ cannot be held responsible for any incurred losses or indirect expenses related to program bookings, such as travel, accommodations, visa fees, or bank transfer charges.

8. IMMIGRATION REGULATIONS

- 8.1 It is the responsibility of students and legal guardians to ensure the legal entry of students into Switzerland.
- 8.2 Students and legal guardians are obliged to adhere to immigration regulations.

9. CONTRACTUAL COMMITMENTS AND SAFETY ACKNOWLEDGMENTS

- 9.1 Upon signing the application form, legal guardians acknowledge the program description, admission conditions, and school and boarding rules as integral components of the contractual agreement.
- 9.2 Dispensations from lessons or leisure activities are not possible except for medical reasons.
- 9.3 Legal guardians confirm their awareness that the participant will engage in sports activities entailing inherent risks, such as skiing, snowboarding, biking, water sports, adventure activities, and the like.

10. GOVERNING LAW AND JURISDICTION

- 10.1 These terms and conditions shall be governed by and construed in accordance with Swiss Laws.
- 10.2 Any disputes arising from these terms and conditions will be subject to the exclusive jurisdiction of the courts of Chur.
